3. **Force Majeure.** I/we understand that this agreement is subject to cancellation due to acts of God, war, government regulation, disaster, strike, civil disorder or any other emergency beyond the parties' control, making it inadvisable, illegal or impossible to perform their obligations under this agreement.

4. **Indemnity.** I/we shall indemnify, defend and hold harmless WOW! Productions, the City of Los Angeles and its officers, directors, agents, volunteers and employees (the "Indemnified Parties") from and against any and all claims, damages, losses and expenses, including attorney fees, arising out of or resulting from the acts, whether active or passive, errors, omissions, conduct or operations of Vendor or its officers, directors, employees, agents, guests and invitees, and each of them.

5. **Waiver of Claims.** I/we assume full responsibility to safeguard all property owned or used by our Performers during the event. I/we waive any claims against the Indemnified Parties for damage to or loss of such property, unless such damage or loss results from the sole negligence, gross negligence or willful misconduct of WOW! Productions, its employees or volunteers.

6. **Security.** I/we will comply with all Cherry Blossom Festival So. Cal. rules, regulations and directives and its security staff. Firearms or facsimiles are not permitted on the festival property unless otherwise approved in advance of the event by the Festival.
